Provided, further that in case of pre primary classes also, this norm shall be followed.

provide a separate bank account.

The Society/School shall not collect any capitation fee and subject the child or 5. his or her parents or guardians to any screening procedure.

6 The School shall not deny admission To any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission.

On the ground of religion, caste or race, place of birth or any of them.
